OFFICE ORDER

Subject: Extended Operational Hold & Suspension of File Allocation – DAMS Agri Private Limited

This is to formally notify all concerned that Mahirdonz Irrigations Private Limited has been associated with DAMS Agri Private Limited for execution of irrigation-related works.

Due to the following continuing and unresolved issues:

- Non-receipt of payments for the past eight (8) months
- Delay and inconsistency in material delivery timelines
- No material credit facility extended till date, unlike other approved companies
- Frequent changes in delivery schedules resulting in operational disruption

the management has decided to impose a LONG-TERM AND STRICT OPERATIONAL HOLD on DAMS Agri Private Limited.

Hold Period

- The operational hold shall be effective from 01.02.2026 – 21.04.2027
- The total hold duration shall be FOURTEEN (14) MONTHS

Further, it is hereby ordered that:

1. No files shall be generated, processed, or allocated to DAMS Agri Private Limited for a minimum period of six (6) months after completion of the initial eight (8) months hold.

2. During this extended hold period, no new work orders, proposals, or farmer files shall be entertained under DAMS Agri Private Limited.
3. Unlike other approved companies where material credit facilities are available, DAMS Agri Private Limited has not provided any material credit support, adversely affecting operations.
4. Material delivery delays and changes have been found unacceptable and detrimental to farmer commitments and district-level execution.

Conditions for Resumption of Work

Resumption of file allocation and services to DAMS Agri Private Limited shall be considered only after the following conditions are fully met and verified:

- All pending payments are cleared in full, and
- All pending materials are delivered, received, and verified by the concerned department.

Only upon written confirmation and approval by the management of Mahirdonz Irrigations Private Limited shall any future files be initiated for DAMS Agri Private Limited.

No exception, deviation, or interim arrangement shall be permitted during the hold period.

This office order is issued for strict information, implementation, and compliance by all departments, field teams, and associated stakeholders.
